

“Send it or Spend it” at Club Whitsunday

#### COMPETITION TERMS AND CONDITIONS

1. Information on how to enter forms part of these conditions. Entry into the competition constitutes acceptance of these terms and conditions.
2. Club Whitsunday is hereby referred to as the promoter.
3. Entry is only open to Club Whitsunday patrons who are members. Employees (and their immediate families) of the promoter and its agencies associated with this promotion are ineligible to enter. Entrants must be over 18 years of age at the time of the competition.
4. The period for entry into the promotion commences on Saturday 1st November 2025 at 10am and finishes on Saturday 1st August 2026 at 8pm.
5. Entries are earned in the following ways:
  - 1 entry per \$5 food spend
  - 1 entry per \$5 beverage spend
  - 1 entry per \$10 gaming turnover
  - 1 free ticket daily by swiping your members card at the members kiosk
6. On the night of the draw, members must activate their entries by using their card within the venue within 4 hours of the draw. Members who do not swipe in through a till, the members kiosk, or a gaming machine will not be validated to be in the draw.
7. The 1st draw is \$1,500 cash at 5pm; the 2nd draw is a \$3,500 XXXX merchandise pack and Cowboys game experience (scheduled for 2026 or 2027 depending on game availability) at 6pm; the 3rd draw is the choice of \$5,000 cash or a \$7,500 holiday at 7pm; and the 4th draw is the choice of \$5,000 cash or a \$7,500 holiday at 8pm.
8. The winners will be announced in the venue on Saturday 1st August 2026 from 5pm. Winners must be present at the venue to win the prize. The winner will have 2 minutes to notify staff they are on site. If the winner is not on site, the prize will be redrawn.
9. All competitions are only conducted at the licensed premises, Club Whitsunday.

10. Total prize pool will not exceed \$20,000.
11. Any additional expense incurred as a result of winning this prize is the responsibility of the winner.

The promoter assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communication line failure, theft, destruction, or unauthorised access to entries.
